The institution **Saras Foundation, Kalamb** had submitted an application under Maharashtra Self Financing School (Establishment & Regulation) Act, 2012 for getting approval to start a new Self Financed English medium school named **Canvas International Smart School, Gat No. 205, A/P Tandulwadi, Tq Kalamb, Dist. Osmanabad (Primary to Higher Secondary School Std. 1st to 12th all streams, English Medium, State Board).**

2. With reference to your application, a Letter of Intent along with the terms and conditions was given for starting the construction of the building for the school on Self-Financing basis under Maharashtra Self Financing School (Establishment & Regulation) Act, 2012 and Maharashtra Self Financing School (Establishment & Regulation) Rules, 2020, from the academic year 2023-24 to **Saras Foundation, Kalamb's Canvas International Smart School, Tandulwadi, Kalamb, Sy. No. 205, Tandulwadi, Tq. Kalamb, Dist. Osmanabad**, with the intention to start English Medium new Primary to Higher Secondary School (from Std. 1st to 12th all streams, English Medium, State Board) on Self Financing basis. Now, the approval for starting the said new School since academic year 2023-24 is hereby given subject to following terms and conditions:

3. Terms & Conditions:

1. The proposed school shall fulfil all standards, criteria, terms and conditions prescribed by Right to Free and Compulsory Education for Children Act, 2009 and Maharashtra Right to Free and Compulsory Education Rules, 2011 and the instructions given by the Government vide this Act and the criteria or standards or terms and conditions that are issued by the Government from time to time.

2. It is compulsory that the registered society or the trust or the company should follow all standards, terms and conditions prescribed by Maharashtra Self Financing School (Establishment & Regulation)

Act, 2012 and the instructions given by the Government vide this Act or the criteria or terms and conditions prescribed by the Government from time to time.

3. It is compulsory for those school managements who are willing to take affiliation of C.B.S.E. or C.I.S.C.E. or C.A.I.E. or I.B. etc. boards, to take No Objection Certificate from the Government, as per the directions given by the Government from time to time.

4. The school management shall inform the Education Officer of the concerned District prior to commencement of the academic year approved by Government.

5. As per the provisions of this Act, the approval given for the starting the new school or extension of standards of the school is applicable for the same academic year in which it is approved.

6. If the school management fails to start the school within 18 months, then the letter of intent issued shall be canceled.

7. The School Management shall not change the medium of education approved, place of school, in future, without the permission of the government.

8. Permission shall be terminated if the school management establishes the school at different place from the one where it is approved by the government.

9. Provision is made to the effect that, the recruitment of teaching and non- teaching staff in the Self-Financing School should be done as per the prevalent rules and regulations of the Government.

10. While filling the information District-wise, the school which has been given approval, such school shall fill the information as independent category "Self- Financing School" and shall obtain U.D.I.S.E. number. In this regard, the State Project Director, Maharashtra Primary Education Council, Mumbai has been declared as a Nodal Officer.

11. The school management shall affix a board on the entry gate of the school campus as "Self-Financing Recognized School".

12. For the reason that, any of the provisions of this act or any of the rules made there under are violated or any of the instructions given vide this act or if fault is committed of the standards prescribed by the Government from time to time or if the standards or terms and conditions are not followed, then State Government shall be entitled to terminate the time. Recognition Letter issued, any time.

Regarding grant of Accreditation Certificate to the Schools in view of Sec. 18 of Right to Free and Compulsory Education Act 2009 for Children, as per Rule 11, Sub. Rule (4) of Right to Free and Compulsory Education for Children Rules, 2011.

With reference to your application dated 19/12/2023 and on the basis of postal correspondence made with the school / inspection of the school undertaken, I, Sudha Salunke, The Education Officer (Primary), Zilla Parishad, Osmanabad, is granting Approval to the school **Canvas International Smart School, Tandulwadi, Kalamb, Sy. No. 205, Tandulwadi, Tq. Kalamb, Dist. Osmanabad** the academic year dated 26.06.2023 to dated 31.03.2025 for Std. 1st to 8th.

The above approval is subject to fulfillment of the following conditions:

1. The period of approval shall not be extended.
2. The school shall comply with the provisions of Free and Compulsory Education to Children Act, 2009 (Enclosure One) and Maharashtra Right of Free and Compulsory Education to Children Act 2011 (Enclosure Two).
3. The school shall impart free and compulsory education to them till the primary education is completed.
4. The institution/school shall not collect any capitation fees and shall not force the child or his or her parents or guardian for any type of scrutiny system.
5. Admission shall not be denied to any child in the school for any of the reasons.
6. (One) Any child having given admission in the school, shall not be detained in the same class in which he is studying or shall not be expelled from the school till completion of primary education.

(Two) No physical punishment or mental harassment shall be given to any child.

(Three) No child shall be required to pass the examination of any of the board till completion of primary education

(Four) Every child having completed the primary education, shall be given a Certificate prescribed as per Rule 23.

(Five) Inclusion shall be made as per the provisions of the Act of Handicapped/students in need of special attention.

(Six) The teachers shall be appointed having minimum qualification prescribed as per Sec. 23 (1) of the Act.

(Seven) The teachers shall discharge their duties as mentioned in Sec. 24 (1) of the Act.

(Eight) It shall be ascertained by the school that the teachers should not engage themselves in the work of private coaching.

7. The school shall comply with the syllabus prepared on the basis of the study course prescribed by the concerned tribunal.

12. The school is being administered by the institution registered under the Societies Registration Act, 1860 (21 of 1860) or by the society registered under Mumbai Public Trust Act, 1950.
13. The school is not administered for the benefit of any person, group or the association of persons or for the benefit of any person or for fetching any profits.
14. The accounts of the school should be duly audited and certified from the Chartered Accountant and the necessary account statements should be prepared as per rule. One copy of every account detailed statement should be sent to The District Education Officer every year.
15. The approval code number received by your school is 27290208202. Please mention this number while making any postal correspondence with this office, which note.
16. The reports and information sought by The Director of Education / District Education Officer must be submitted time to time and for removing the discrepancies in the working of the school, all instructions must be followed.
